Sam D'Souza, who 'brokered deal', surfaces; says Wankhede not involved, NCB witness Gosavi pretended to be in touch with him

Dadani did not respond to calls or text messages from The Indian Express. Since the interview aired, D'Souza's number has been switched off. Wankhede had earlier denied that he was part of any deal with Dadani. Gosavi was arrested in a cheating case in Pune last week. D'Souza's name cropped up last month when Prabhakar Salka, a witness in the alleged drugs case who claimed to have been employed as a bodyguard by Gosavi, alleged that he heard Gosavi speaking on the phone with D'Souza, asking him to strike a deal with Dadani for Rs 25 cr, of which Rs 8 cr would be given to Wankhede.

D'Souza told the TV channel that he arranged a meeting between Dadani and Gosavi in the early hours of October 3 to 'broker a deal'. 'Dadani, her husband, Gosavi, and some others met at Lower Parel around 4 am on October 3,' he claimed. D'Souza said he left the spot, and was later informed that Gosavi had taken Rs 50 lakh from Dadani to 'help' Aryan.

He claimed that at the rendezvous in Lower Parel, Gosavi's phone rang and he showed him the call ID which said 'Sameer Sir'. But he alleged, Gosavi had saved Salka's number. Under that name, and showed it, among other things, to the press.

According to D'Souza, after Aryan's arrest, Gosavi called him to say that Aryan wanted to speak with Dadani. Gosavi also told him that no drugs were found on Aryan's person and they could 'help' him. D'Souza said he got in touch with Dadani through some 'friends'. Asked about his relations with the NCB and allegations that he was a drug peddler, D'Souza said he had no second and was a businessman. He said that in the past, whenever he got information about narcotics, he had passed it on to NCB officials.

Maik claims Wankhede's 'lavish lifestyle funded by extortion', he denies

MUMBAI: NAWAB Malik on Tuesday targeted NCB Zonal Director Sameer Wankhede for his 'lavish lifestyle' and made public his sister Yasmeen Wankhede's purported WhatsApp chats with a now jailed drug peddler. 'While Wankhede claims to be an honest officer, he says that cost over Rs 30,000, which is worth my 2 lakh and watches that are worth my 1 lakh. I want to know how a government employee can afford to live this lifestyle,' Maik said. He said that the expensive clothes worn by Wankhede were beyond the reach of an honest and upright officer and that his lifestyle was funded through extortion money. 'He employed a private army to frame people and extort money from them. Cases have been-

inted by Wankhede,' Maik said. Maik also questioned the delay in the probe of the drug case related to the death of actor Sushant Singh Rajput. He said it has been 14 months and that thousands of crores have been extorted in this time span. 'Wankhede has been fined for an offence reported in the case over 14 months. According to the NPS Act, a charge sheet is supposed to be filed within six months,' Maik said, adding that money was extracted from well known actors under the garb of investigations. Maik asked if a Whistleblower that purportedly belongs to Yasmeen, who is a lawyer, and a drug peddler had admitted his sister for legal representation, but was told that she did not have money to pay for it. 'A (drug) peddler, Salmaan, approached my sister... but she doesn't take NPS cases, so she sent him back.

Salmaan tried to bribe me a middleman. He was arrested and his bribe allegations are being levelled by charlatans. What's up that, 'Maik asked the NCB. On claims about his lifestyle and expensive clothes, Wankhede said these were 'rumours'. 'As far as my expensive clothes are concerned, it is just a rumour,' he said. An NCB official said that a person had approached Wankhede's sister, a lawyer who deals with cases of crime against women and minors, with a query related to a sexual assault case. for forensic testing, and they are awaiting the reports. 'The report will be submitted in the court and it will find some evidence necessary action will be taken,' Malhotra told The Indian Express.

Malik alleged that this particular FIR was not closed as it was to be used to target Bollywood which was a target of Deshpande and Rajal Preet Singh being kept quiet for questioning. The NCB, however, said it was awaiting forensic reports, following which further course of action will be decided. The FIR was registered by NCB headquarters in Delhi and has nothing to do with the Mumbai unit headed by Sameer Wankhede, an official said. After the death of actor Sushant Singh Rajput and after the CBI and ED registered cases against Rhea and some of her family members, the ED retrieved some chats from Rhea's phone that mentioned narcotics. The chats were given to NCB and an FIR 15/2020 was registered against Rhea, her brother Shekhar, Rajput's cook Dipesh Sawant, housekeeper Sameer Miranada, talent manager Joushna, former manager Shruti Modi and Goa-based hotelier Gaurav Ayya.

However, two days later the NCB registered another FIR 16/20 and arrested Rhea in that case. Along with her, Shekhar, Rajput's house help and another 30 persons were arrested by the NCB in the case. A charge sheet was subsequently filed in March this year. There was, however, no development in 15/20.

The case was investigated by JDS Malhotra, the then deputy director of NCB headquarters. It was in relation to some chats that had been found in Rhea's phone that the NCB had summoned Deshpande and Rajal Preet Singh for an interview. However, no charges were made in the case nor was it charge sheet.

Who asked about a NCB official had in the past said that it was just an 'enquiry FIR' that was registered on the basis of the chats. 'The chats were made in the FIR registered later,' the official said. Malhotra said that some of the mobile phones seized in the case were sent
